The Lyon County Fiscal Court met in regular session, Thursday, October 14, 2021 at 1:00 pm with the following members present: Judge Wade White, Magistrates Bobby Cummins, Quin Sutton, Jeff Fowler and County Attorney Lee Wilson.

Judge White called the meeting to order. Magistrate Quin Sutton gave the invocation and the court led the pledge to the flag.

During visitor comments, several members of the Worthington Subdivision Home Owners Association and the Rolling Mill Home Owners Association, approached the court with concerns of a stop sign at the intersection of Rolling Mill Road and North Worthington Way.
