JOINT MOTION TO ADOPT CERTAIN RESPONSES TO DATA REQUESTS

Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") (collectively, the "Companies") move the Kentucky Public Service Commission ("Commission") to allow Lonnie E. Bellar, the Companies' Chief Operating Officer, to adopt the responses to data requests filed in this proceeding sponsored by Daniel K. Arbough (regarding Ohio Valley Electric Corp. ("OVEC") matters), Christopher D. Balmer, Michael P. Drake, and John K. Wolfe. The Companies further move the Commission to allow Christopher M. Garrett, the Companies' Controller, to adopt the responses to data requests filed in this proceeding sponsored by Daniel K. Arbough that do not relate to OVEC.

The Companies further move the Commission to allow Mr. Bellar to testify at the hearing scheduled in this proceeding instead of Messrs. Arbough (regarding OVEC matters), Balmer, Drake, and Wolfe, and further to allow Mr. Garrett to testify instead of Mr. Arbough regarding non-OVEC matters relevant to Mr. Arbough's responses to data requests.

In support of this motion, the Companies state that allowing these adoptions and testimony substitutions are necessary in part due to recent retirement and role change events, and they will increase the administrative efficiency of the hearing by reducing the number of witnesses.

Further, on June 24, 2022, counsel for the Companies advised counsel for the Commission and the intervenors of this proposal by electronic mail. The Companies are not aware of any

opposition to this motion, and the Attorney General has authorized the Companies to represent that the Attorney General does not oppose this motion.

WHEREFORE, the Companies ask the Commission to issue an order:

- 1. Allowing Mr. Bellar to adopt the responses to data requests filed in this proceeding sponsored by Messrs. Arbough (regarding OVEC), Balmer, Drake, and Wolfe;
- 2. Allowing Mr. Garrett to adopt the responses to data requests filed in this proceeding sponsored by Mr. Arbough that do not relate to OVEC;
- 3. Allowing Mr. Bellar to testify at the hearing scheduled in this proceeding instead of Messrs. Arbough (regarding OVEC matters), Balmer, Drake, and Wolfe; and
- 4. Allowing Mr. Garrett to testify instead of Mr. Arbough regarding non-OVEC matters relevant to Mr. Arbough's responses to data requests.
