**ATTORNEY GENERAL’S MOTION TO AMEND PROCEDURAL SCHEDULE**

The intervenor, the Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention [“OAG”], hereby moves the Commission to amend the procedural schedule in this matter to allow one additional week, until April 22, 2022, within which for intervenors to file their comments, and to add one additional week for all remaining deadlines currently on the procedural schedule.

In support of this motion, counsel for OAG states that his office is currently engaged in several Commission dockets requiring significant amounts of time and effort which are under inflexible statutory time deadlines. Moreover, an extension of time in the instant docket: (i) should not impact the remaining deadlines in the procedural schedule (especially since no hearing has been scheduled in this matter); and (ii) should not prejudice any party. Additionally, OAG notes that counsel for LG&E-KU has advised him that LG&E-KU have no objection to OAG’s motion, and has authorized him to represent such. Finally, OAG has no objection to LGE-KU’s motion filed on April 5, 2022 for leave to file written responses to intervenor comments.

WHEREFORE, counsel for the Attorney General respectfully requests that the Commission grant his motion.
