APPLICANTS’ PROOF OF NOTICE OF HEARING

In compliance with the Kentucky Public Service Commission (“PSC”) Order of June 1, 2023, New Cingular Wireless PCS LLC d/b/a AT&T Mobility (“AT&T”) and Tillman Infrastructure LLC, a Delaware limited liability company (“Tillman”) (collectively, “Applicants”), by counsel, hereby file the attached documentation proving that notice required by the previously referenced Order and 807 KAR 5:001E, Section 9(2)(b) has been performed appropriately.

The Applicants also published notice of the hearing in the Grayson County News, a newspaper of general circulation in Grayson County, Kentucky, within the time prescribed by 807 KAR 5:001E, Section 9(2)(b)2 and including the content (purpose, time, place, and date of hearing) required by 807 KAR 5:001E, Section 9(2)(b)4. A copy of the tearsheet and affidavit confirming publication of the notice advertisement are attached as **Exhibit D**.

WHEREFORE, the Applicants, by counsel, request the PSC to accept this Response for filing and grant Applicants any other relief to which they are entitled.

New Cingular Wireless PCS, LLC, a Delaware limited liability company, d/b/a AT&T Mobility and Tillman Infrastructure LLC, a Delaware limited liability company have filed an application with the Kentucky Public Service Commission ("PSC") to construct a new wireless communications facility on a site located at 2589 Blue Bird Road, Falls of Rough, KY 40119 (37° 35' 48.02" North latitude, 86° 29' 24.53" West longitude). The proposed facility will include a 145-foot tall tower, with an approximately 4-foot tall lightning arrestor attached at the top, for a total height of 149-feet, plus related ground facilities. This facility is needed to provide improved coverage for wireless communications in the area.

This notice is being sent to you in compliance with a PSC Order issued on June 1, 2023. The order can be viewed on the PSC website, psc.ky.gov.

A hearing for this matter shall be held on July 27, 2023 at 9 a.m. eastern daylight time and continuing until called from the bench by the presiding officer, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.

This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov. Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, psc.ky.gov.

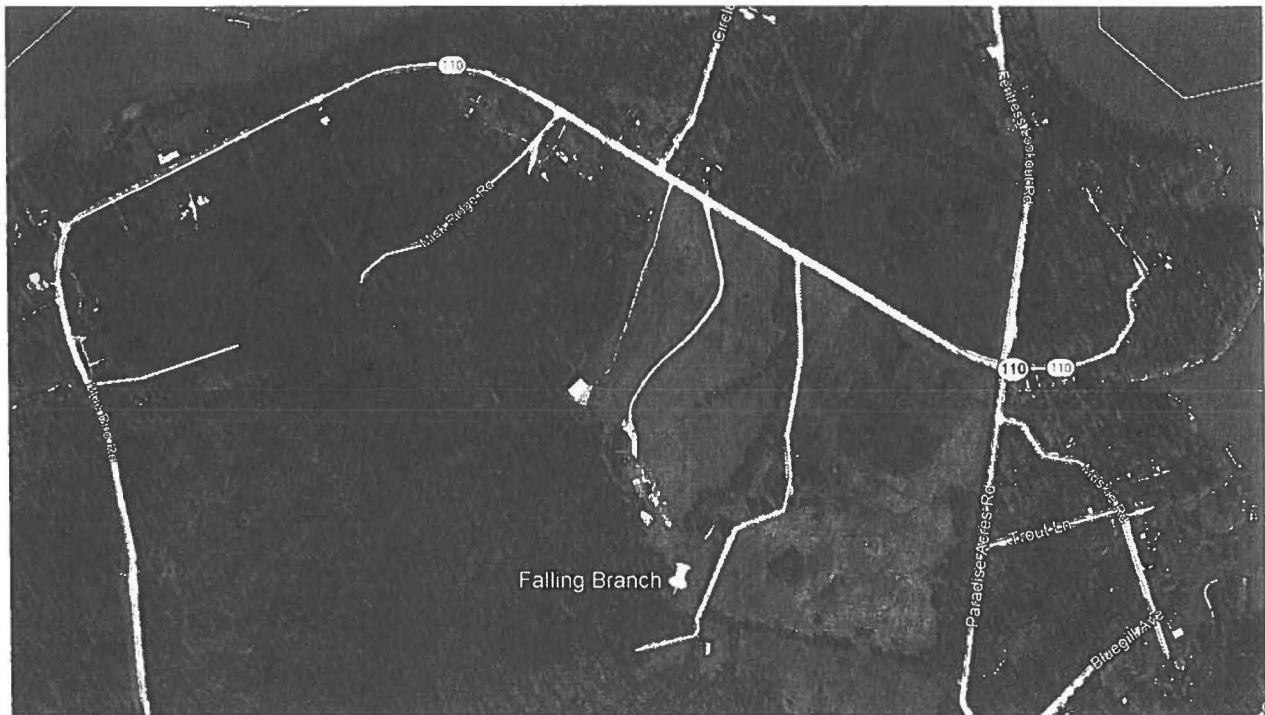

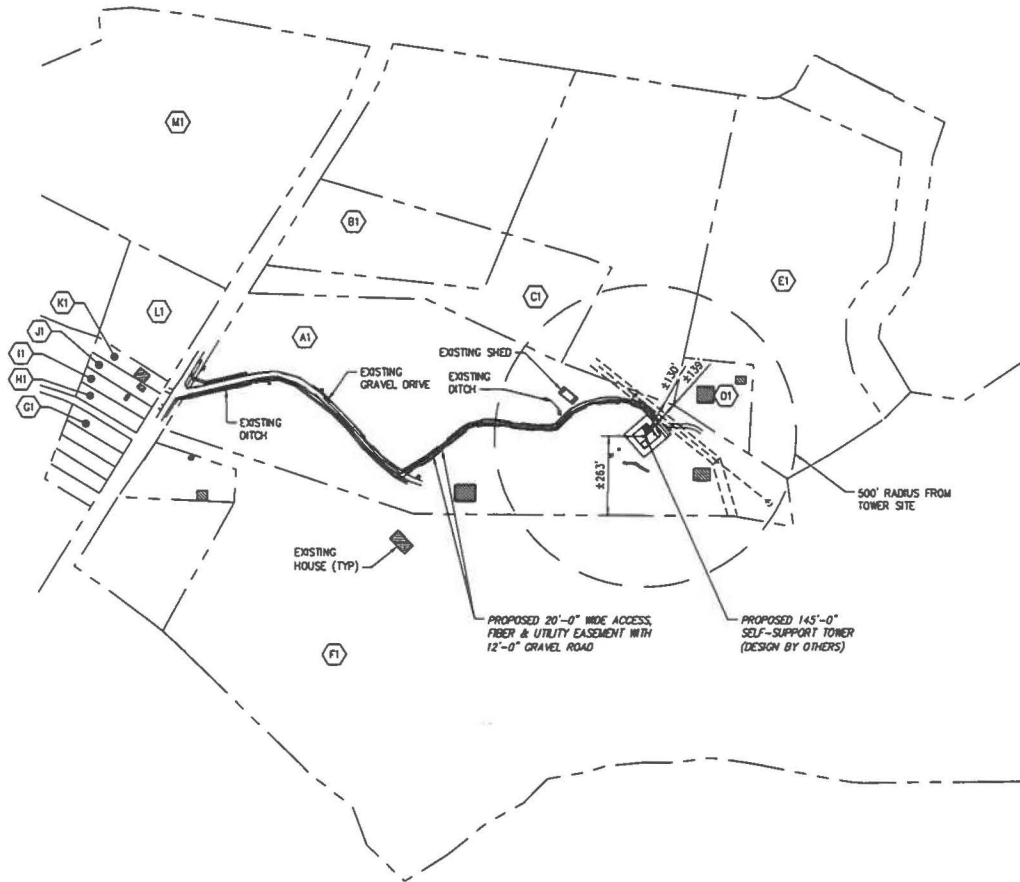
Driving Directions to Proposed Tower Site

1. Beginning at 130 E. Market Street, Leitchfield, KY 42754, head west on E Market Street toward S Heyser Drive and travel approximately 459 feet.
2. Turn right at the 2nd cross street onto S Main Street and travel approximately 459 feet.
3. At the traffic circle, take the 3rd exit onto Public Square and travel approximately 410 feet.
4. Follow Public Square as it turns slightly right and becomes W Main Street and travel approximately 0.9 miles.
5. Continue onto KY-54 W / Owensboro Road and travel approximately 10.0 miles.
6. Turn right onto KY-79 N and travel approximately 5.8 miles.
7. Turn right onto KY-110 and travel approximately 0.4 miles.
8. Turn right to stay on KY-110 and travel approximately 0.9 miles.
9. Turn left to stay on KY-110 and travel approximately 1.3 miles.
10. The site is located on the right at 2589 Blue Bird Road, Falls of Rough, KY 40119.

 - b. West 86 deg 29 min 24.53 sec



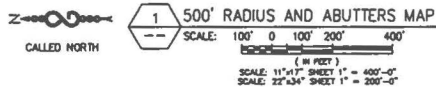

Article 2 BUILDING; ZONING; DEMOLITION PERMIT ISSUANCE; FEE

2.31 Application - In applying to the Planning Commission and its authorized agent or inspector for a building, additions to existing structures, renovation or (and) zoning permit, the applicant shall submit a dimensioned sketch or scale plan indicating lot dimensions, the shape, size, height, and location of all buildings to be erected, altered, or moved, and of any building already on the lot or parcel. It shall be stated as to the existing and intended use of all such buildings and supply such other information as may be required by the Commission and its authorized agent or inspector for determining whether the provisions of the chapter are being observed and upheld. The County Health Officer's certificate approving proposed water and sewerage facilities must accompany applications according to Section 4.1.8 of this Ordinance.

2.32 Issuance - If the proposed excavation or construction as set forth in the application are in conformity with the provisions of this chapter and other ordinances of the city then in force, the authorized agent or inspector shall issue a permit for such excavation.
