The tapping fees collected in 2020 were \$6,800. The labor and materials associated with these were expensed in 2020. The Schedule of Adjusted Operations reduced labor costs for the test year by 30% of the amount of the tapping fees collected or \$2,040 and reduced materials costs by 70% of the tapping fees collected or \$4,760.
