MOTION FOR DEVIATION

Comes now South Kentucky Rural Electric Cooperative Corporation ("South Kentucky RECC"), by counsel, pursuant to 807 KAR 5:001 Section 22 and other applicable law, and for its Motion requesting that the Kentucky Public Service Commission ("Commission") grant a deviation from a portion of the regulation addressing notice of hearing, 807 KAR 5:001 Section 9(2)(b)2, respectfully states as follows:

- 1. South Kentucky RECC submitted its notice of hearing to twelve newspapers which are the newspapers of general circulation in South Kentucky RECC's service territory. Specifically, South Kentucky RECC provided the notice of hearing to *Adair County Community Voice, The Adair Progress, The Casey County News, Clinton County News, Cumberland County News, The Sentinel Echo, Interior Journal, McCreary County Voice, Commonwealth Journal, Mt. Vernon Signal, Russell County Times Journal and The Wayne Weekly Newspaper.*
- 2. South Kentucky RECC requested the hearing notice to appear in each of these newspapers on April 27th or April 28th depending on the day the newspaper was published.
- 3. Ten of the twelve newspapers ran the hearing notice as requested by South Kentucky RECC. Please see the affidavits and tear sheets that are being filed with the Notice of Proof of Hearing Notice contemporaneously with this Motion.

- 4. However, two of the twelve newspapers, failed to publish the hearing notice as requested by South Kentucky RECC. *Adair County Community Voice* provided an email to South Kentucky RECC, which is attached to this Motion as Exhibit 1, that stated the provided hearing notice was lost in the production department and was never published. *Russell County Times Journal* printed a blank box where the hearing notice should have been printed and has provided an email saying it was inadvertently left out of the of the newspaper. The email is attached to this Motion as Exhibit 2.
- 5. South Kentucky RECC did not learn of these errors until proof of publication was requested from the newspapers by which time it was impossible to request another publication prior to the May 10, 2022 hearing because they are weekly newspapers. In the case of *Adair County Community Voice*, notice of the hearing was properly published in another Adair County newspaper, *The Adair Progress*, providing sufficient notice to the citizens of Adair County. Therefore, South Kentucky RECC is requesting a deviation from the regulation for the failure of these two newspapers to publish the hearing notice as requested and provided by South Kentucky RECC.

WHEREFORE, on the basis of the foregoing, South Kentucky RECC respectfully requests that the Commission grant a deviation from 807 KAR 5:001 Section 9(2)(b)2.
