**BLUE MOON ENERGY'S REVISED NOTICE OF INTENT**

Comes now Blue Moon Energy LLC, by counsel, pursuant to KRS 278.700, et seq., 807 KAR 5:110, Section 2 and other applicable law, and does hereby tender its Notice of Intent to file an application, on or before January 31, 2021, for a Certificate to Construct an approximately 70 megawatt ("MW") merchant solar electric generating facility and an unregulated transmission line in Harrison County, Kentucky (the "Blue Moon Energy Project"), respectfully stating as follows:


1. Pursuant to 807 KAR 5:110, Section 2(2)(a), the forthcoming application will be filed by Blue Moon Energy LLC, 3000 E. Cesar Chavez St., Suite 400, Austin, TX 78702. The applicant's telephone number is: 859-993-0077 and its email address is: BlueMoon@RecurrentEnergy.com.
2. Pursuant to 807 KAR 5:110, Section 2(2)(b), the Blue Moon Energy Project will be capable of generating approximately 70 MW of electricity from a solar array covering a total of approximately 651 acres. The project will connect to a substation to be constructed on the site. The substation will connect to a transmission line via an unregulated transmission line to be constructed entirely within the project footprint.

3. Pursuant to 807 KAR 5:110, Section 2(2)(c), the Blue Moon Energy Project is located in Harrison County, KY, near Cynthiana, Kentucky. The Project's street address is 694 Ky Highway 1940, Cynthiana, KY 41031. Its coordinates are: 38.371664 latitude and - 84.257759 longitude. No portion of the Blue Moon Energy Project is located within the boundaries of any municipality.
4. Pursuant to 807 KAR 5:110, Section 2(2)(d), the Harrison County Planning Commission has jurisdiction over the site and is located at 111 S. Main Street, Suite 202, Cynthiana, Kentucky, 41031.
5. Pursuant to 807 KAR 5:110, Section 2(2)(e), the relevant Harrison County Zoning Ordinance requires setbacks of 100 feet in the front, 50 feet on the sides, 50 feet to the rear, and 200 feet from any residential structure or dwelling.
6. Pursuant to 807 KAR 5:110, Section 2(2)(f), the applicable setback requirements are less stringent than the requirements set forth in KRS 278.704(2). Thus, a deviation request will not be necessary.
