Notice is hereby given that the Kentucky Public Service Commission (the "Commission") will conduct a public hearing in Case No. 2021-00421 beginning at 10:00 a.m. Eastern Daylight Time on Wednesday, March 30, 2022 in the Richard Raff Hearing Room (Hearing Room 1) at its offices at 211 Sower Boulevard, Frankfort, Kentucky 40601. The hearing will address the proposed modifications to the Mitchell Plant Ownership Agreement. The hearing is for the purposes of presenting and cross-examining witnesses supporting the parties' positions and rebutting the other parties' evidence.
