Notice is hereby given that the Kentucky Public Service Commission (the "Commission") will conduct a public hearing beginning at 9:00 a.m. Eastern Standard Time on Tuesday, March 1, 2022 in the Richard Raff Hearing Room (Hearing Room 1) at its offices at 211 Sower Boulevard, Frankfort, Kentucky 40601. The hearing is scheduled to continue on March 2, 2022 beginning at 9:00 a.m. Eastern Standard Time and March 3, 2022 beginning at 9:00 a.m. Eastern Standard Time. The hearing is for the purposes of cross-examination of the witnesses of Kentucky Power Company and taking evidence on the issues in Case No. 2021-00421 regarding Kentucky Power Company's request for approval of affiliate agreements related to the Mitchell Generating Station.
