Visitors were Mr. Michael Guill, and Mr. Larry Mitchum.

Mr. Guill told the board that CCWD has run a water line on his property without an easement. He said that there has been spraying to kill undergrowth on his property and that there has been cutting done on his property. He wants a meter "for the damage" because he alleges the water district ran the line without an easement. He alleges he's not responsible for any damage to the water line because the water line was run without an easement. He doesn't know how long the water line has been on his property. Mrs. Fralick told him that the issue will need to be researched, and he can come back to a meeting, or a letter can be sent to him. Mr. Noel asked him if he wanted a letter, or if he wanted to come to a meeting. Mr. Guill wants to come to the next meeting. When asked what lead him to come to the meeting now, Mr. Guill implied he's had sight issues and recently noticed there had been spraying/cutting on his property. Mr. Littlefield addressed Mr. Guill's implication that he pushed him out the door of the district office. Mr. Littlefield says he was not the aggressor.

- I am working on pricing for the master meters that will be used for leak detection and to help with water quality.
