Commissioner Mincarelli addressed the Board regarding the Water Purchase Contract amendment presented by City of Williamstown for the Boards consideration. The agreement sets forth a defined 6 year water purchase rate table. If signed, the Board would agree the preset rate increases are fair and reasonable. Based on her November discussion with Williamstown, several changes were to be made to the offer before presentation to the Board for further review. The Amendment offered by Williamstown presents very little benefit to Corinth Water District over the existing Contract terms last signed into agreement by Commissioner Field in the December 2013 amendment. As of the date of the board meeting, Williamstown had not presented an amended water purchase offer for review.

Ms. Wright provided a copy of the Water District's ledger detailing the District's payments, deposits and adjustments, as well as the totals from the District 's bank accounts for the Boards review. Commissioner Kennedy made a motion to pay the Water Districts Sams' Club credit bill in total. Commissioner Mincarelli seconded the motion. All Commissioners were in favor. Commissioner Mincarelli made a motion for approval of the monthly balances and reports. Commissioner Kennedy made a second of the motion. All Commissioners were in favor.

As there was no more business to discuss, Commissioner Field motioned for adjournment of the meeting. Commissioner Mincarelli seconded the motion. All Board members were in agreement. The meeting was adjourned.
