### **AMENDED NOTICE**

This Amended Notice is hereby given to amend Kentucky-American Water Company's December 1, 2021 notice of its request to adjust wastewater rates. The amended requested rates are set forth below and have been submitted for approval to Public Service Commission, Frankfort, Kentucky, for an adjustment of sewer rates with the rate change to be phased in over a four-year period in Case No. 2021-00434. New rates are expected to become effective no later than August 28, 2022. The first adjustment is for service rendered in August 2022; the second adjustment is for service rendered in August 2023; the third adjustment is for service rendered in August 2024; and the fourth adjustment is for service rendered in August 2025. With all four adjustments, the total amount of the requested increase is \$940,985 on an annual basis, which is an increase of 137.39%.
