Interview with Carlise Police Chief Bill Denton

On Friday afternoon, August 11, 2023, I spoke by phone with Carlisle Chief of Police Bill Denton about a few issues.

Regarding the recent retirements and resignations of the entire Carlisle Police force, Chief Denton confirmed that he would be the only one staying on. He told me that Officer Gary Kinder would be retiring on Sat., August 12, 2023, and that Sgt. Matt Royse and K-9 Officer Drew Merrill had submitted their resignations, with their last day being on Tues., August 15, 2023.

A Facebook post over the weekend on the Carlisle Police Department – Kentucky Facebook page ments of both Officer Jeff Lizer and Officer Gary Kinder. Officer Lizer had 42 years of Law Enforcement service having served the communities of Paris/Bourbon County Carlisle/Nicholas County. The post remarked, "His dedication and experience will be very much missed in the day-to-day operations of this department." The post also mentioned Officer Kinder "who is also retiring today after a very rewarding career."

Chief Denton mentions that he had a total of 7 officers altogether, and that all of them would be gone, pending resignations and retirements, except for him. I asked Chief Denton if the resignations were all because the city would

not pay hazard pay, and that if any compromise was made to try to get the officers to stay on, and he said that I would have to speak with the resigning officers to find out exactly why they left and under what circum-

I asked what the city was doing to bring in more officers to help out, and he said the city was currently in the hiring process and looking at applications. Mayor Ronnie Clark mentioned Monday evening's City Council meeting that he was hoping to have 2 officers hired by the end of the week. I asked Chief Denton on the phone, that until he receives those new officers, would he be working hand-in-hand with Nicholas County Sheriff Jeff Sidles and the Kentucky State Police, and he remarked, "That is correct."

Due to the shortage of officers here in Carlisle, there will be random patrols throughout the city, and don't be surprised if the Sheriff or the KSP show up to a local call, standing in for the Carlisle Police Department.

I then asked about the recent WKYT News Investigation regarding the Cheyenne Clifford case. Chief Denton remarked, "I officially have no comment on WKYT's investigation.'

WKYT had a news investigation this past week regarding a 911 call that was called into dispatch regarding a red Dodge truck "all over the roadway" and with "passengers hanging out the window." Carlisle Police Officer Jamie Copher located the vehicle at Shell gas station at 9:49 P.M. and issued a verbal warning to Mr. Clifford, a few hours before the deadly crash that killed Nathaniel Welch and Gage Gaunce and injured two others, while Mr. Clifford only sustained minor injuries. An indictment handed down by the Nicholas County Grand Jury on June 19, 2023, included 11 total charges, including No/Expired Registration Plates and Failure of Owner to Maintain Required Insurance – First Offense, amongst the 11 charges. Upon watching the news clip, the WKTY News Investigation left out a lot of important details, including the

fact that after being

Mr. Clifford and his passengers drove to the Gyp Joint located in Pleasant Valley in Nicholas County. Surviving passenger Emily Earlywine told Nicholas County Sheriff Jeff Sidles that Mr. Clifford was drinking heavily at the Gyp Joint in Pleasant Valley in Nicholas County, for approximately an hour, while the other 4 passengers were not permitted inside. An altercation inside the establishment angered Mr. Clifford, and he and his occupants left. The crash happened just a

few minutes later. Cheveene R. Clifford is currently being held in the Bourbon County Detention Center on a \$500,000.00 cash bond.





Why You Should Designate Beneficiaries (Part 2)

If you have any of the following, check to ensure you have the person or persons you want to receive the assets listed as beneficiaries (continued next month).

- Retirement accounts In addition to traditional IRAs and Roth IRAs, there are other types of IRAs, such as SEP IRAs and SIMPLE IRAs. Reviewing the beneficiary designations on all types of retirement accounts is essential.
- Annuities Annuities provide regular payments to individuals over time, typically as a source of retirement income. Most plans allow you to select one or multiple beneficiaries.
- Pension Plans If you pass away before retirement, some pension plans provide lump sum payments to named surviving loved
- Bank accounts Pay-on-death or transfer-on-death bank accounts allow you to list beneficiaries who assume ownership of your account after you pass away. This is different from a joint account, where you and another person both own the assets. In a pay-on-death account, your beneficiary takes ownership after you pass. You can add and change beneficiaries directly through your financial institution.
- Investment accounts Like other financial accounts, investment accounts can be transferred to a recipient upon the owner's death.
- Health savings accounts You can obtain the necessary form to transfer your health savings account by contacting your HSA provider or visiting their website.
- Life insurance policies Those with life insurance policies typically select who will receive the payment when they establish their policy. However, policyholders should remember to review and update their plans when circumstances change, such as after a divorce
- House When you create a transfer-on-death deed, you can transfer your house upon your death and bypass probate. For older adults, this can be a safer option than adding someone to the deed, as it preserves their full ownership of the property until death.
- Car Certain states allow people to name a transfer-on-death beneficiary for their vehicles.
- Business Interests If you own a business, be sure to review partnership agreements, shareholder agreements, or operating agreements for transfer provisions.
- •Digital Assets Some online platforms allow you to assign someone to manage your digital accounts after your death.

Multiple Beneficiaries and Successors

In many cases, you may name more than one beneficiary. For instance, a person with two children might want to leave an asset to them both. Depending on the type of asset, you can state how much of the asset each child receives.

It is also vital to consider successor beneficiaries. A successor obtains the asset if the original recipient passes away. For instance, you could list a beneficiary and a successor on a pay-on-death account.

Changing Beneficiaries

You can change whom you listed as a beneficiary as your relationships and circumstances evolve. When you designate a beneficiary on an asset such as an account, they assume ownership only after you die. Generally, they will not have an ownership interest while you are alive and can handle your own affairs.
