EXHIBIT A

Detailed Project Description

Bracken County Water District – Additional Project Description

The BCWD originally planned to replace their main feed of potable water for their entire customer base, an approximate 35 year old 10" PVC water main located in the floodplain. The main originated from the City of Augusta WTP and proceeded along and near the river bottom of the Ohio River. This portion of the project involved replacing approximately 5,250 LF of the water main with new 12" ductile iron water main. This portion of the replacement ensured that all water main would now be located outside of the floodplain and would be constructed of material far less likely to suffer from breaks and leaks.

Near completion of this portion of the project the District began discussions and preparations to replace an additional 2,100 LF of this 35 year old 10" PVC water main. The original water main proceeds along and almost parallel with Augusta Berlin Road and ends at the District's approximate 200,000 gallon clearwell and main pumpstation that feeds its entire distribution system. Although this portion of the water main is located outside of the floodplain it is still of the older PVC material and has been prone to leaks and breaks due to the age and material of the water main. The District believed that given the current environment as it relates to supply chain issues and Covid that it would be prudent to attempt to go ahead and replace this additional 2,100 LF of water main to ensure that the entirety of the District's main feed from the City of Augusta was of newer and more reliable material. With completion of this portion of the project the District will have a new ductile iron water main from the City of Augusta, the District's main supplier, to the District's clearwell and main pump station.
