
C. CONDITIONS OF SERVICE

B&S shall not be liable to an applicant for any discontinuance, reduction, change or any other effect on service to the applicant resulting from: the plugging, shut-in, abandonment (temporary or final), or change in the use of any well or wells, temporary or permanent discontinuance or reduction of transportation of gas through any applicable pipeline; the use (or termination of use) of compressors or other equipment; breakage or maintenance of pipelines or other equipment; changes in B&S's operations; or other causes related to B&S operations or business activities, any or all which may be undertaken in B&S's sole discretion. B&S is under no obligation to supply any specific quantity or quality of gas to an applicant. The applicant understands and acknowledges that the gas B&S supplies is untreated; is not artificially odorized; may not be consistent in volume, Btu content or other qualities; and may have Btu content higher or lower than gas transported in interstate pipelines or supplied by gas distribution companies.

D. APPLICATION FOR GAS SERVICE

B&S will require applicants to complete and sign an Application for Gas Service Pursuant to 807 KAR 5:026, Section 3, before service is supplied. The use of natural gas service constitutes an agreement under which the Customer receives natural gas service and agrees to pay the Company therefore in accordance with the applicable Tariff, and agrees to comply with the Rules and Regulations established by the PSC of Kentucky and the terms and conditions of the company (B&S). The company may refuse service to any customer who fails to comply with the Rules, Regulations, Terms, and Conditions of B&S. B&S will not furnish service to any applicant who owes the company any past due amount for service at any location, until all such indebtedness is paid n full.




