APPROVAL OF MINUTES

Judge/Executive Coyle called for any additions, corrections, or amendments to the minutes of the Regular Fiscal Court Meeting of August 14, 2018. Hearing none, these minutes stood approved as presented.

REPORTS

Treasurer's Report (Sabra Garmon) – Treasurer Garmon reported the financial status through today with the total cash amount of \$5,882,920.84, plus receipts of \$371,425.74 and \$569,944.85, less payroll of \$217,162.31, less claims of \$268,985.79. \$57,382.05, \$2,537.00, and \$898.00, less a certificate of deposit of \$400,000.00, leaving an adjusted money market checking account balance of \$5,877,326.28.

<u>Maintenance Superintendent, Rick Wade</u> asked the court for permission to re-advertise for a custodian position for the Maintenance Department.

1. A motion was made by Gary Finnell and seconded by Mary Ann Gill to re-advertise for a custodial position for the Maintenance Department.

Superintendent Wade also asked the court to approve the costs for light repair at the football stadium. Costs included \$506.25 for a bucket truck, \$461.50 for lighting, and \$300.00 for the repair.

Also, damage was done to the handrail by the sheriff's office during the Twilight festival. A police report has been made and a claim will be filed with insurance.

Lastly, three quotes were received for fence repair at the Millville Community Center following the flooding event that occurred. The quotes received were \$6,500.00, \$6,800.00, and \$11,175.00. He is still waiting on the final approval on the claim before proceeding with the repair.

Recycling, Joe Girouard handed out information regarding the household hazardous waste event and waste tire event.

<u>Road Supervisor, Bo Wilson</u> informed the court that all subdivisions have been cleaned up and asked the court for permission to rent an excavator to remove storm debris that had been taken to Recycling.

3. A motion was made by Jackie Brown and seconded by Ken Reed to approve the rental of an excavator to remove storm debris from the Recycling Center.

Mr. Chandler also informed the court that the generator on Big Sink Pike that is no longer operational has been turned into insurance and a claim number has been assigned. Director Chandler asked the court for permission to advertise for bids for the purchase of a new generator.

4. A motion was made by Ken Reed and seconded by Mary Ann Gill to allow Emergency Management Director Drew Chandler to advertise for bids to purchase a new generator for the building on Big Sink Pike.

Squire Watts thanked the sheriff's office, police department, and all the individuals that assisted with the flooding that occurred in the Millville area.

Squire Gill informed the court she has received complaints from people that live in Sugartree. They are having difficulty seeing to pull out due to hedges and a mailbox at a house on Huntertown Road. Squire Brown is going to contact the Road Committee and investigate further.

County Attorney, Alan George informed the court that the title search on the fire district property is very involved and is taking some time. He will let the court know when it is completed. Also, Mr. George reminded candidates of the 35 day rule regarding yard signs. They should not be set out before October 1st and should not be placed in rights of way or medians. Lastly, Mr. George commended Treasurer Garmon on her work with Air B&B. The Lane Report did an article on the agreement and there are only 4 entities in the state with such an agreement – the Commonwealth of Kentucky, Louisville, Lexington, and Woodford. We are the first fiscal court government to have such an agreement, so Treasurer Garmon is to be commended on her work on this project.

Judge/Executive Coyle thanked court members for donating money for the brunch for city and county employees. He also reminded the court that Treasurer Garmon is still accepting money for another Veterans Hall of Fame sign to put at the county line on US 60.
