NOTICE is hereby given that the Kentucky Public Service Commission has scheduled a public hearing in a case styled “An Examination of the Application for the Fuel Adjustment Clause of Duke Energy Kentucky, Inc. from May 1, 2021 through October 31, 2021,” Case No. 2022-00040, beginning Thursday, August 4, 2022, at 9:00 a.m., Eastern Standard Time, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky for the purpose of examination relating to Duke Energy Kentucky’s fuel adjustment clause from May 1, 2021 through October 31, 2021.
