RESPONSE TO ORDER OF OCTOBER 21, 2022

Big Sandy Water District ("Big Sandy District") submits this response to the Public Service Commission's Order of October 21, 2022.

Attached to this Response as Exhibit A is a table containing the metering reading dates, billing periods, and bill issuance dates for all billing cycles from August 1, 2022 through December 31, 2023. Big Sandy District reads its meters on the first workday of the month. It generally requires two workdays to complete meter reading. The District then prepares and mails bills based upon those readings on the last work day of the month. The issuance date on the bill is the first day of the following month.

Big Sandy District proposes that the Phase 1 rates approved in the Order of September 13, 2022 be first applied to **bills issued on December 1, 2022**. Bills issued on December 1, 2022 will cover **service provided to customers on and after October 3, 2022**, depending upon the date the customer's meter was read. The billing period for bills issued on December 1, 2022 will begin on **October 3 or 4, 2022** and run to **November 1 or 2, 2022**. Meter readings for these bills will occur **on November 1 or November 2, 2022**.

¹ Because two workdays are generally required to complete meter reading, approximately one-half of all meters will be read on **October 3** and one-half on **October 4**. The effective date of the newly approved rates for service for those customers whose meter is read on the second workday will be **October 4**, 2022.

Big Sandy proposes that the Phase 2 rates approved in the Order of September 13, 2022 be first applied to bills issued on December 1, 2023. Bills issued on December 1, 2023 will cover service provided to customers on and after October 2 or 3, 2023, depending upon the date the customer's meter was read. The billing period for bills issued on December 1, 2023 will begin on October 2 or 3, 2023 and run to November 1 or 2, 2023. Meter readings for these bills will occur on November 1 or November 2, 2023.

In its Order of October 21, 2022, the Commission ordered that the charges for non-recurring services approved in the Order of September 13, 2022 have the same effective date as the monthly water rates. Therefore, the effective date for the newly approved charges for non-recurring services would be **October 3, 2022.** Those charges would be applied to any non-recurring services provided on or after October 3, 2022 and would be reflected on bills issued on **November 1, 2022.**

In its Order of October 21, 2022, the Commission ordered that the charges for non-recurring services approved in the Order of September 13, 2022 have the same effective date as the monthly water rates. Therefore, the effective date for the newly approved charges for non-recurring services would be **October 3, 2022.** Those charges would be applied to any non-recurring services provided on or after October 3, 2022 and would be reflected on bills issued on **November 1, 2022.**
