**APPLICANTS’ SUPPLEMENTAL RESPONSE
TO COMMISSION STAFF’S SECOND DATA REQUEST**

New Cingular Wireless PCS, LLC, a Delaware limited liability company, d/b/a AT&T Mobility and Tillman Infrastructure LLC, a Delaware limited liability company (collectively “Applicants”), by counsel, make this Supplemental Response to the Kentucky Public Service Commission Staff’s Second Request for Information to New Cingular Wireless PCS, LLC d/b/a AT&T Mobility and Tillman Infrastructure dated July 27, 2023. The aforesaid filing supplements Applicants’ Response to Commission Staff’s Second Data Request dated August 7, 2023 (“August 7, 2023 Response”). Applicants respectfully state, as follows:

1. As noted in their August 7, 2023 Response, Applicants previously determined

that an adjoining parcel (Parcel #: 099-00-00-026.00) was owned by the Daniel Boone National Forest (“National Forest”). Applicants initially provided notice of the proposal to an address they identified as the National Forest Supervisor’s Office. However, while preparing their August 7, 2023 Response, Applicants identified a different address for the National Forest Supervisor’s Office listed on the United States Forest Service website (see August 7, 2023 Response, **Exhibit J-3**). Accordingly, Applicants sent notice of the proposal to this address and agreed to supplement the record when a signed green card was received or returned as undelivered.

2. Applicants recently received the returned signed green card for the notice letter sent to the National Forest, and a copy of that document is attached as **Exhibit J-4**. As shown on the returned signed green card, notice of this proposal was received by the National Forest on August 4, 2023. Having submitted all signed or returned undelivered green cards, Applicants’ have fully complied with the Commission Staff’s Data Requests.

3. An Affidavit certifying that the response is true and accurate to the best of that person’s knowledge, information, and belief formed after a reasonable inquiry has been signed by the attorney supervising the preparation of the response on behalf of Applicants’ and is included as **Exhibit 1**.

WHEREFORE, there being no ground for denial of the subject application and substantial evidence in support of the requested CPCN, Applicants respectfully request the Kentucky Public Service Commission:

- (a) Accept this Response for filing;
- (b) Issue a Certificate of Public Convenience and Necessity to construct and operate the WCF at the location set forth herein without further delay; and
- (c) Grant Applicants any other relief to which they are entitled.



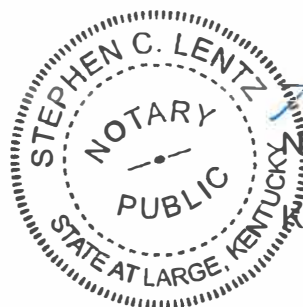
