#### NOTICE OF PROPOSED ELECTRIC TRANSMISSION LINE CONSTRUCTION PROJECT

Kentucky Utilities Company ("KU") proposes to construct approximately eight (8) miles of 345 kV electric transmission lines, and construct approximately six (6) miles of 138 kV electric transmission lines in Hardin County. The construction of the lines would help meet the growth in the area, including Ford Motor Company's two proposed battery manufacturing plants, and the expected additional associated industries. A map showing the route of the proposed lines is shown below.

KU plans to file an application with the Kentucky Public Service Commission ("Commission") on or after March 31, 2022, seeking a certificate of public convenience and necessity authorizing construction of the proposed transmission lines. The purpose of the Commission's review of KU's application is to determine whether the proposed transmission lines are required by the public convenience and necessity. Any interested person, including a person whose property will be crossed by the proposed transmission line, may request intervention in this proceeding, and may request that the Commission conduct a public hearing in Hardin County.

If the Commission does not receive a written request for intervention within thirty (30) days of initial publication or mailing of the notice, the Commission may take final action on the application.
