Comes now, Kirksville Water Association (KWA), through counsel, and for its Application to assume indebtedness states as follows:

- 1. KWA is a water association created and existing under and by the virtue of Chapter 74 of the Kentucky Revised Statutes. KWA is a Kentucky non-profit corporation that was organized on 7/15/1970, is currently in good standing and is duly licensed and authorized to operate in Kentucky.

- 3. That Kirksville Water Association, pursuant to KRS 273.300, seeks an order approving the application to assume indebtedness to secure a building for their office.
- 4. KWA purchased property at 1613 Foxhaven Drive to house its office and operations. The original cost of applicant's property is \$237,500.00. KWA financed \$174,500.00 at 4.5% with 1st Trust Bank in Richmond, KY. The note is payable over 84 months with a balloon payment due on November 18, 2028 and is secured by a mortgage against 1613 Fox Haven Drive, Richmond, KY 40475. The property will only be used for KWA purposes.

- 5. Attached with this application is a financial statement covering KWA's most recent 12 months of operations. There have been no material changes since the 12-month period ended.
- 6. Kirksville Water Association has no other debt besides the attached bonds and the mortgage that is the subject of this petition.
- 7. Kirksville Water Association owns two small parcels of property that contain a water tower and a pump station. Those deeds are attached. There are no debts associated with these properties.
- 8. Kirksville Water Association owes no other debts for equipment or of any other kind.

WHEREFORE, pursuant to KRS 278.300, KWA respectfully requests permission to assume indebtedness of \$174,500.00 over 7 years at 4.5% interest with 1st Trust bank for the purpose of providing a headquarters for their operations.
