In compliance with the Kentucky Public Service Commission’s (the “Commission”) Order entered on May 9, 2024, (the “Order”), approving Bluegrass Water Utility Operating Company, LLC’s (“Bluegrass Water”) motion for confidential treatment related to Bluegrass Water’s Application for a Certificate of Public Convenience and Necessity (“CPCN”) to install a moving bed biofilm reactor (“MBBR”) treatment system and a solids handling system at its Delaplain wastewater treatment plant (“Delaplain”) in Scott County, Kentucky, and Ordering Paragraph 2 thereof, Bluegrass Water hereby provides notice to the Commission that construction has commenced at the Delaplain plant.

1. The Commission entered two orders in this matter on May 9, 2024, the Order identified above, and the Final Order approving Bluegrass Water’s request for a deviation from the plans approved by the Commission in its order entered on March 30, 2023.

2. Pursuant to Ordering Paragraph 2 of the Order, Bluegrass Water hereby notifies the Commission that construction began at the Delaplain plant on April 1, 2025.
