EAST KENTUCKY POWER COOPERATIVE, INC.'S NOTICE CONCERNING HEARING AND BRIEFING

Comes now East Kentucky Power Cooperative, Inc. ("EKPC"), by and through counsel, pursuant to the Commission's June 3, 2022 Order denying the Kentucky Broadband and Cable Association's ("KBCA") Motion for Clarification and does hereby give notice of its position on whether a hearing and/or briefing schedule is necessary in this proceeding, respectfully stating as follows:

KBCA filed a motion on May 12, 2022 requesting to file legal briefs in lieu of, or simultaneously with, intervenor and rebuttal testimony. In a June 3, 2022 Order, the Commission denied KBCA's motion and stated that the parties should confer and file a statement with their respective positions on or before July 18, 2022. Pursuant to the Commission's Order, the undersigned has consulted with his client and shared multiple email exchanges with counsel for KBCA and the distribution rural electric cooperative corporations.

EKPC's position is that the tariff it has filed is straightforward and does not require either a hearing to elucidate the language thereof or to clarify any interpretative questions. Likewise, EKPC does not believe that there are any legal issues arising from or relating to its proposed tariff and, therefore, does not believe that any briefing is necessary. Nevertheless, should the

Commission determine that a hearing, briefing or both of them are necessary, it reserves the right to fully participate in either or both activities.
