BellSouth Telecommunications, LLC d/b/a AT&T Kentucky (“AT&T Kentucky”) and Cheryl R. Winn, a member of the Bar of the Commonwealth of Kentucky in good standing, move the Kentucky Public Service Commission to admit John T.
