RESPONSES OF CINCINNATI BELL TELEPHONE COMPANY, LLC D/B/A ALTAFIBER TO COMMISSION STAFF'S THIRD REQUEST FOR INFORMATION

- 1. Refer to Cincinnati Bell's response to Commission Staff's Second Request for Information, Item 1(b).
 - a. Explain the need for a minimum application fee of \$250.

RESPONSE: In response to Staff's Second Request for Information, Item 1(b), altafiber reported that the engineering time to perform pole field surveys averaged 0.7 hour per pole. However, in cases involving only one pole, the average time to conduct the field survey was 2.875 hours, when two poles were involved, the average time per pole was 1.1 hours (2.2 hours for the request as a whole), and when there were more than two poles the field survey took a minimum of 4 hours. Adding the administrative cost to process the application and the time to prepare make ready estimates, there was no case where the total cost was less than \$250.

b. Explain whether the prepaid survey fee will be trued-up once all survey work is complete. If so, indicate the section of the tariff stating such.

RESPONSE: The application fee under-recovers the costs incurred to process the application, but altafiber does not bill the applicant for the shortfall. There is nothing to true-up.
