APPLICANTS' RESPONSE TO COMMISSION STAFF'S SECOND DATA REQUEST

New Cingular Wireless PCS, LLC, a Delaware limited liability company, d/b/a AT&T Mobility and Tillman Infrastructure LLC, a Delaware limited liability company (collectively "Applicants"), by counsel, make this Response to the Kentucky Public Service Commission Staff's Second Request for Information to New Cingular Wireless PCS, LLC d/b/a AT&T Mobility and Tillman Infrastructure dated July 28, 2023. Applicants respectfully state, as follows:

Question 1: Refer to Joint Applicants' response to Commission Staff's First Request for Information, Exhibit J-2. Explain why Joint Applicants served the Pine Knot Cemetery at the address used and any considerations taken into account for service of a cemetery.

- 1. As required by applicable statutes and regulations, Applicants obtained the records from the McCreary County Property Valuation Administrator ("PVA") for the Pine Knot Cemetery property (Parcel #: 140-00-00-042.01). The PVA records are the official records maintained by the County to ensure landowners receive notice of any taxes due on the property. As shown on **Exhibit J-1** of Applicants' Response to Commission Staff's Data Request dated June 23, 2023 ("Response to First Data Request"), the PVA's record for this property does not list a mailing address or specific physical address for the owner of the Pine Knot Cemetery property. From publicly available information, Applicants determined the Cemetery's physical address and sent notice to that address, as documented on the returned notice letter attached as Exhibit J-2 of Applicants' Response to First Data Request. During the course of preparing this response, Applicants identified an entity listed on the Kentucky Secretary of State website as the "Pine Knot Cemetery Association, Inc." A copy of the organization listing for this entity is attached as **Exhibit J-3**. Applicants' have attempted to provide notice of the proposal to that entity by mailing a certified notice letter to the last known registered agent. A copy of the green card receipt is attached as Exhibit J-3. Applicants will supplement the record when a signed green card is received or returned undelivered.
- 2. An Affidavit certifying that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry has been signed by the attorney supervising the preparation of the response on behalf of Applicants' and is included as **Exhibit 1**.

WHEREFORE, there being no ground for denial of the subject application and substantial evidence in support of the requested CPCN, Applicants respectfully request the Kentucky Public Service Commission:

- (a) Accept this Response for filing;
- (b) Issue a Certificate of Public Convenience and Necessity to construct and operate the WCF at the location set forth herein without further delay; and
- (c) Grant Applicants any other relief to which they are entitled.
