**Property Acquisition Update**

Kentucky Power files with the Commission its January 2025 property acquisition update. The filing is being made in accordance with paragraph 44 of the Company’s application. This update details the status of Kentucky Power’s property acquisition efforts as of January 1, 2025. No opposition has been expressed.

The Company has now acquired 55 of the 61<sup>1</sup> parcels affected by the transmission line or its right-of-way. **EXHIBIT 1** provides further information regarding the status of the 61 parcels.
