RE: Formal Application to Increase Rates Pursuant to Purchased Water Adjustment Regulation 807 KAR 5:068

Dear Ms. Bridwell:

The Green-Taylor Water District respectfully requests that the Commission allow for an adjustment to our rates in accordance with 807 KAR 5:068 Purchased Water Adjustment clause.

The District was recently notified by its supplier, Campbellsville Municipal Water, that it would increase its wholesale rates by \$0.18 per 1000 gallons. This increase took effect on August 1, 2021. The result of this increase is \$24,689.16 in additional yearly supply cost for the District. This translates into \$0.09 per 1000 gallons of water sold to our customers. Therefore, we propose to increase our rates by that amount.

The Campbellsville Water & Sewer Committee met on May 13, 2021 and recommended to the Campbellsville City Council an increase in Green-Taylor Water District's rate for water service from Campbellsville Water.

The Wholesale Water Rate for Green-Taylor Water District will increase from \$2.20 per 1000 gallons to \$2.38 per 1,000 gallons.

The Campbellsville City Council had its First Reading of the proposed rate increase on Monday, May 17, 2021, and the Second Reading will be heard on Monday, June 21, 2021.

The proposed rate increase will be effective for water used on and after August 1, 2021.

The monthly bill for a customer using an average of 4,688 gallons of water each month will increase from \$48.04 to \$48.46. This is an increase of \$0.43 or 0.87%.

The charges/rates contained in this notice are the charges/rates proposed by the Green-Taylor Water District. However, the Public Service Commission may order charges/rates to be charged that differ from these proposed charges/rates. Such action may result in charges/rates for consumers other than the charges/rates detailed in this notice.
