Notice is hereby given that the West Laurel Water Association, Inc. expects to file an application with the Kentucky Public Service Commission on or about April 15, 2022, seeking approval of a proposed adjustment to its water rates. The proposed rates shall not become effective until the Public Service Commission has issued an order approving these rates.

If the Public Service Commission approves the proposed water rates, then the monthly bill for a customer using an average of 4,000 gallons per month will increase from \$41.36 to \$45.31. This is an increase of \$3.95 or 9.55%.

The rates contained in this notice are the rates proposed by West Laurel Water Association, Inc. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates shown in this notice.

West Laurel Water Association, Inc. has available for inspection at its office the application which it submitted to the Public Service Commission. A person may submit a timely written request for intervention to the Public Service Commission, PO Box 615, Frankfort, KY, 40602, establishing the grounds for the request including the status and interest of the party. If the Public Service Commission does not receive a written request for intervention within thirty (30) days of the initial publication of this notice, the Public Service Commission may take final action on the application.
