Notice is hereby given that South Hopkins Water District (“District”) will file an application for a rate increase. Case number 2022-00122. Consequently, notice is hereby given that the District plans to file an application with the PSC on or about April 26, 2022 seeking approval of a proposed rate adjustment. The proposed rates shall not become effective until the PSC has issued an order approving these rates.

If the PSC approves the proposed rates, then the monthly bill for a customer using an average of 4,000 gallons per month will increase from \$33.90 to \$36.14. This is an increase of \$2.24 or 6.5%.

The rates contained in this notice are the rates proposed by the District, but the PSC may order rates to be charged that differ from the proposed rates contained in this notice. Such action may result in rates for consumers other than the rates shown in this notice.

Any person may submit a timely written request for intervention by mail to the Public Service Commission, Post Office Box 615, Frankfort, KY 40602. The request for intervention must establish the grounds for the request including the status and interest of the party. The request may also be submitted by emailing it to PSCED@ky.gov. If the PSC does not receive a written request for intervention within thirty (30) days of the initial publication or mailing of notice, the PSC may take final action on the application for a rate adjustment.
