As you are aware, construction bids for the above referenced project were received and opened on March 3, 2022. A copy of the Bid Tabulation is attached for your reference.

The lowest responsive, responsible Base Bid (basis of Award): United Pipeline, Inc. - \$1,098,580.00

Alternate 1 Bid:

United Pipeline, Inc. - \$78,000.00

Alternate 2 Bid:

United Pipeline, Inc. - \$422,940.00

In review of the Bids, Jessamine County Water District No. 1 (JCWD1) determined at their April regular Board meeting to also include Alternate No. 1 to the base bid - to install 200 new radio read meters, thereby increasing development costs by \$78,000.00, to a revised total of \$1,176,580.00
