MOTION FOR EXTENSION OF TIME

The City of Eddyville, Kentucky ("the City") moves for additional 14 days in which to response to the requests of Commission Staff. In support of its motion, the City states:

- 1. On June 20, 2022, Commission Staff issued a request for information to the City and directed that the requested information be furnished no later than July 11, 2022.
- 2. Following receipt of this request, counsel for the City contacted Commission Staff and discuss possible means by which the Commission's review of the City's proposed wholesale rate adjustment could be expedited. The City suggested that Commission Staff identify any other information that would facilitate the Commission's review and offered to provide such information as part of its response to Commission Staff's initial request for information. Commission Staff by electronic mail has identified this information.
- 3. The City is gathering the information requested in the request for information and that subsequently identified by Commission Staff. Some of the requested information is in the records of other parties, such as the Kentucky Infrastructure Authority. The City has requested this information from these other parties and is working diligently with those agencies to obtain the requested documents.
- 4. The City requests an additional 7 days to submit the requested information. In addition to the requested information, it intends to provide additional documents and information

to fully explain the need for proposed wholesale rate adjustment and to demonstrate the proposed adjustment's reasonableness.

5. The requested extension is sought in good faith and not for purposes of delay.

Wherefore, the City requests that the Commission extend the time period for submission of a response to Commission Staff's First Request for Information to July 18, 2022.
