**WAIVER OF RIGHT TO HEARING  
AND MOTION TO SUBMIT MATTER FOR DECISION**

Wood Creek Water District (“Wood Creek District”) hereby waives its right to a hearing in this matter and moves that the record in this proceeding be closed and that this matter stand submitted for decision, except to permit the filing of a final report on rate case expenses no later than November 15, 2022.

In support of its Motion, Wood Creek District states:

1. There are no intervenors in this matter.
2. Wood Creek District has filed an application in this matter that consists of approximately 220 pages.
3. Commission Staff has served upon, and Wood Creek District has responded to, three extensive requests for information that cover every aspect of Wood Creek District’s operations during the test period.
4. The existing record is well developed and more than adequate for the Commission to evaluate and render a decision upon Wood Creek District’s application for rate adjustment.


5. Dispensing with a hearing in this matter will result in significant savings in time and resources for both Wood Creek District and the Commission and expedite a final decision in this matter.

6. Wood Creek District requests that the record remain open only for the purpose of allowing the submission of a final report on rate case expenses no later than November 15, 2022.
