- 1. Submit the necessary documents to support a rate increase proposal to PSC
- 2. Complete conflict questionnaire
- Provide a Notice to customers regarding a rate increase, including a Notice to the City of Sturgis

After examining the annual report from 2020 and making necessary adjustments (i.e. addition of late fees based upon 2019 fees, less tapping fees, and new employee rates). If authorized, Mr. Miller will prepare appreciation package with supporting documents for the Alternate Rate Filing (ARF) to be submitted to PSC.

Must advertise 1 week before appreciation is made and 2 weeks after appreciation is submitted.

This will be filed electronically to Kentucky Attorney General Office and to PSC. PSC will review it and go through the checklist. PSC will then send a Notice of No Deficiencies, then will issue a calendar which may entail approximately 6 months.

PSC will provide a report to Commissioners who will then issue an Order.
