The Union County Fiscal Court met in regular session with the Honorable Adam O'Nan presiding. Due to the Corona Virus the Union County Fiscal Court met in the upstairs Courtroom so that social distancing could be practiced and the meeting was livestreamed on Facebook. Magistrates present were Wyatt, Floyd, Byrnes and Clements.

The minutes from the May 25, 2021 meeting were accepted as read.

Judge O'Nan made a recommendation to re-appoint Joyce Greenwell to a four-year term to the Union County Water District Board of Commissioners. Magistrate Clements made a motion to accept the recommendation, seconded by Magistrate Floyd, motion carried.

Judge O'Nan presented a Resolution for Adoption of the 2021Green River Area Development District Hazard Mitigation Plan Update. Magistrate Floyd made a motion to adopt the Resolution Update, seconded by Magistrate Clements, motion carried.

At our May 25, 2021 Fiscal Court Meeting, Judge O'Nan presented to the Court the Appraisal, in the amount of \$50,000, for the building that the Union County Water District rents from us and is wanting to purchase. At that meeting, Judge O'Nan stated that the Water District had, at their own expense, purchased a new air conditioning unit for \$4,700 for the building and asked the Court if they wanted to take the \$4,700 off of the purchase price, lowering it to \$45,300 or leave it at the appraised amount of \$50,000? When Judge O'Nan presented the building to the Water District for \$50,000, they made a counter-offer, stating that they would like to be reimbursed the \$4,700 for the new air conditioning unit, either by subtracting it from the \$50,000 purchase price or by them paying the \$50,000 and then the County reimbursing them the \$4,700 for the a/c. Magistrate Floyd made a motion to approve the Water District paying \$50,000 and the County reimbursing them \$4,700 for the air conditioning unit and having the invoice go in with today's claims, seconded by Magistrate Wyatt, motion carried. County Attorney, Julie Wallace, is going to draw up the deed and will then get it to Judge O'Nan.

Also, at our May 25, 2021 meeting, Tom Dempewolf with Sonitrol of Evansville gave a presentation to the Court regarding new security systems at our Senior Citizens Building and our Animal Control Building. After talking to County Attorney, Julie Wallace, Judge O'Nan said

He doesn't anticipate that we'll have any trouble with getting it and as soon as he hears something he will let the Court know.

Judge O'Nan stated that after meeting with EMA Director, Rick White and Magistrate Wyatt, in looking over the Turn-Out bid that we received at the May 25th meeting, they recommended that we reject the bid and re-advertise. Judge Veatch declared the Public Hearing open to receive comment on the County Rural Aid funds for 1996-97. Being no comment either oral or written the hearing was declared closed.

Judge Veatch declared the Public Hearing on the LGEA Funds opened. Their being no written or oral comments on the use of these funds o the budgeting of the 1996-97 budget, the hearing was declared closed.

The Union County Water District requested that the salaries of the three board members serving on the Water Board be increased from \$3000.00 per year to \$3600.00 per year. The Union County Water District submitted a claim in the amount of \$6000.00 for lines installed in District 6. A motion to allow this claim was made by Magistrate Clements, seconded by Magistrate McLeod, motion carried.

Judge Veatch recommended the hiring of M & M Cleaning Management, Inc. in the amount of \$1315.00 per month for the cleaning of the new AOC Building. Magistrate Clements made a motion to hire M & M Cleaning Management, Inc. for the cleaning of the AOC Building. Magistrate Taylor seconded the motion, motion carried.

Magistrate McLeod made a motion to appoint Dennis O'Nan to the Tax Appeals Board as the Fiscal Court's Appointee Magistrate Taylor seconded the motion, motion carried.

Magistrate Austin made a motion to set the price for the 911 Map Book at \$7.50 for the unlaminated copies and \$15.00 for the laminated copies. Magistrate Wells seconded the motion, motion carried.

Magistrate Clements made a motion to accept the Treasurer's Report for March, Magistrate Wells seconded the motion, motion carried. Magistrate Austin made a motion to accept the quarterly report, Jenkins seconded the motion, motion carried. (financial)

Magistrate Wells made a motion to allow the claims, Magistrate Jenkins seconded the motion motion carried.

Magistrate Taylor made a motion to place an ad in the Union County Fair Book at a price of \$100.00. Magistrate Joe Clements seconded the motion, motion carried, with Magistrate McLeod voting may.

Magistrate McLeod made a motion that in the future all bids be sealed and delivered to the Fiscal Court. Magistrate Wells seconded the motion, motion carried.

There being no further business, Magistrate Austin made a motion to adjourn, Magistrate Taylor seconded the motion. Motion carried and meeting was adjourned.

The Minutes of the regular meeting of June 11th, 1991, were read and approved.

A discussion was held regarding the contribution to the Kentucky Rural Water Association Construction Fund for the purpose of constructing a building in Frankfort, Kentucky. Manager Morgan reported he felt it would be worthwhile to make the contribution because of the services the Kentucky Rural Water Association provides to the District. The recommended contribution was three (3) times the annual dues. The annual dues this year were \$285.20; this figure multiplied by three (3) would be \$855.60. Upon motion by Gerald Hunter, seconded by Billy Don Greenwell, a contribution of \$855.60 to the Kentucky Rural Water Association was unanimously approved.

A discussion was then had regarding the operating manual discussed at a previous meeting. Engineer Ron Gastineau advised Manager Morgan the Kentucky Rural Water Association could prepare the manual for \$500 to \$1,000. This was as opposed to Mr. Gastineau's previous quote of \$7,500 to \$10,000 should their engineering firm be asked to prepare the manual. It was decided Manager Morgan should look into this further.

Manager Bill Morgan reported we had paid \$339,287.97 on the Blueberry Hill Project, which left approximately \$98,000.00 in the construction account. He indicated the cost of construction would come out very close to the funds available.
