MOTION TO ALLOW VIRTUAL EXAMINATION OF WITNESS CONSTANCE HEPPENSTALL, PROJECT MANAGER FOR GANNETT FLEMING VALUATION AND RATE CONSULTANTS, LLC

Comes now the Northern Kentucky Water District ("NKWD"), by and through counsel, pursuant to 807 KAR 5:001, Section 9, and other applicable law, and moves the Kentucky Public Service Commission ("Commission") to allow for the virtual examination of witness Constance Heppenstall ("Ms. Heppenstall"), Project Manager for Gannett Fleming Valuation and Rate Consultants, LLC.

In support of this motion, NKWD states that its application was filed on July 22, 2022 and no party has intervened.
