Dear Ms. Bridwell:

The Green-Taylor Water District respectfully requests that the Commission allow for an adjustment to our rates in accordance with 807 KAR 5:068 Purchased Water Adjustment clause.

The District was recently notified by its supplier, Campbellsville Municipal Water, that it would increase its wholesale rates by \$0.38 per 1000 gallons. This increase becomes effective on August 1, 2022. The result of this increase is \$51,108.24 in additional yearly supply cost for the District. This translates into \$0.18 per 1000 gallons of water sold to our customers. Therefore, we propose to increase our rates by that amount.
