APPLICATION

Pursuant to KRS 74.020(9), Barkley Lake Water District ("Barkley District") and Ted Martin, apply to the Public Service Commission for an Order authorizing a, less than six-month, extension of time, until September 30, 2022, for Commissioner Martin to complete the required water district training required for new commissioners pursuant to KRS 74.020(8)(b).

In support of its Application, the parties state:

1. The full name and address of Barkley Lake Water District is P. O. Box 308, Cadiz, Kentucky 42211.
2. Commissioner Martin's full name and post office address is Ted Martin, 79 Shawnee Court, Cadiz, Kentucky 42211.

4. Barkley Lake Water District is not a corporation, limited liability company, or limited partnership. It has no articles of incorporation or partnership agreements.

5. Barkley Lake Water District is a water district created under the provisions of KRS Chapter 74.

6. KRS 365.015 does not require Barkley Lake Water District to file a Certificate of Assumed Name.

7. Commissioner Martin is a new member of the Barkley Lake Water District Board of the Commissioners. He was appointed on August 2, 2021 and his initial training would have to be completed by August 1, 2022. The next training, before this Application, was to be held at Pikeville, Kentucky, but that would cause a financial and logistical strain on Commissioner Martin and the District. The next training session after Pikeville is to be held in Cadiz, Kentucky at the Lake Barkley State Resort Park. Attending that training, in September, would be one (1) months beyond

his requirement for training but would be well within the time allowed for an extension. The minutes of the Trigg Fiscal Court appointing Commissioner Martin are attached hereto and incorporated herein by reference as Exhibit 1.

8. Pursuant to KRS 74.020(6), Barkley Lake Water District has established an annual salary of \$3,600.00 for each member of Barkley Lake Water District's Board of Commissioners and the commissioner must complete his educational requirement as directed by the statute.

9. The Public Service Commission has the authority to grant a reasonable extension of time, not to exceed six (6) months, to complete the training requirements of 74.020(6) for good cause shown. Barkley Lake Water District and Commissioner Martin believe that they have shown good cause to allow for the extension.

10. Barkley Lake Water District and Commissioner Martin request that the Public Service Commissioner grant Commissioner Martin an extension of time until September 30, 2022 to complete the required training for new commissioners.

WHEREFORE, the District and Commissioner Martin requests that the Public Service Commission:


1. Issue an Order extending time in which Commissioner Martin must complete the required instructional

training to qualify to serve as a commissioner and to receive his salary.

2. Enter an Order granting the requested relief, without holding an evidentiary hearing in this matter, no later than August 1, 2022; and

3. Grant any and all other relief to which the District and the commissioner may be entitled.






Magistrate's Comments:
