He advised he was not there to point fingers at anyone for the reason the sirens were not activated during the December 11, 2021, tornado, but that the majority of the sirens worked when tested a week later. He stated Hart County was fortunate to have had no deaths or serious injuries and was proud how all the citizens came together to help each other. Judge/Executive Joe Choate stated through this disaster the court had learned the outdoor sirens need to be on a routine maintenance schedule. The county has contracted to have a service provider to trouble shoot the sirens and give estimates of repairs and the county will come up with a maintenance schedule of the county owned outdoor warning sirens. He closed stating the outdoor warning sirens should not be your only form of severe weather warnings since the sirens are only heard clearly outside and approximately only 1.2 miles from the siren site. NOAA weather radios, local TV/weather stations, wireless notification alerts, weather apps along with friends and family are other notification options that should be used. Judge/Exec Joe Choate stated you cannot just rely on just one form of notification and the Hart County Fiscal Court is exploring several forms of severe weather alert notifications, storm shelters and funding for these projects. Lt. Baker from the KSP, fire fighters and several citizens were in attendance to discuss the concern.

He advised he was not there to point fingers at anyone for the reason the sirens were not activated during the December 11, 2021, tornado, but that the majority of the sirens worked when tested a week later. He stated Hart County was fortunate to have had no deaths or serious injuries and was proud how all the citizens came together to help each other. Judge/Executive Joe Choate stated through this disaster the court had learned the outdoor sirens need to be on a routine maintenance schedule. The county has contracted to have a service provider to trouble shoot the sirens and give estimates of repairs and the county will come up with a maintenance schedule of the county owned outdoor warning sirens. He closed stating the outdoor warning sirens should not be your only form of severe weather warnings since the sirens are only heard clearly outside and approximately only 1.2 miles from the siren site. NOAA weather radios, local TV/weather stations, wireless notification alerts, weather apps along with friends and family are other notification options that should be used. Judge/Exec Joe Choate stated you cannot just rely on just one form of notification and the Hart County Fiscal Court is exploring several forms of severe weather alert notifications, storm shelters and funding for these projects. Lt. Baker from the KSP, fire fighters and several citizens were in attendance to discuss the concern.
