**MOTION FOR EXTENSION OF TIME TO RESPOND TO  
COMMISSION’S FEBRUARY 16, 2023 ORDER**

---

Comes now Rowan Water, Inc. (“Rowan Water”), by and through counsel, and respectfully moves the Kentucky Public Service Commission (“Commission”) for an extension of time to provide the February 2023 legal expenses. In support of this motion, Rowan Water respectfully states as follows:

1. On February 16, 2023, (“February 16 Order”) the Commission issued an Order expanding the case to include an investigation into Rowan Water’s board of directors and general manager regarding certain actions pertaining to the timing of filing the application in this proceeding and lease agreements for vehicles.

2. In the February 16 Order the Commission ordered Rowan Water to bifurcate the legal expenses incurred with respect to the rate portion of this proceeding and the investigation portion of this proceeding.

3. The Commission ordered Rowan Water to file its legal expenses incurred to date by February 28, 2023.


4. Rowan Water filed its rate case expense through December 31, 2022 in this proceeding on February 1, 2023. Rowan Water is filing contemporaneously with this Motion the invoice for legal work performed for the month of January 2023. However, Rowan Water's invoice for legal services performed for February 2023 will not be finalized in the billing system and available to provide until early to mid-March.

5. Rowan Water requests the Commission to allow Rowan Water to file its February 2023 legal expenses on or before March 15, 2023 and to make its monthly filings of rate case expenses on or before the 15<sup>th</sup> day of each month until the closing of this proceeding. This will allow the invoices to be finalized and reviewed by Rowan Water prior to filing with the Commission.

WHEREFORE, on the basis of the foregoing, Rowan Water respectfully requests that the Commission grant Rowan Water an extension until March 15, 2023 to file its invoice for legal services rendered for February 2023 and to allow Rowan Water to make its monthly filings of legal expenses on or before the 15<sup>th</sup> day of each month.
