Over the past several months you have received updates (via mail) regarding the Bright Mountain Solar Project (Bright Mountain) near Hazard, KY. In the spirit of continued transparency regarding the status of Bright Mountain, Avangrid (developer of Bright Mountain) is excited to inform you that Bright Mountain received its Certificate of Construction Permit via the Kentucky State Board on Electric Generation and Transmission Siting on March 13<sup>th</sup>, 2024.

Avangrid operates energy assets in 24 U.S. states with approximately 8,000 employees generating more than 8,700 megawatts of renewable energy. We are truly excited to be granted the approval to extend our national renewable energy generation capacity into the Commonwealth via Bright Mountain.
