The hearing is scheduled to continue at 9:00 a.m. Eastern Standard Time on Tuesday, November 29, 2022. The hearing will address the amortization period and recovery mechanism for the Rockport Deferral Regulatory Asset and the credit for the Rockport Fixed Costs Savings and Rockport Offset. The hearing is for the purposes of presenting and cross-examining witnesses supporting the parties' positions and rebutting the other parties' evidence.
