Court recognized Jailer Thomas Brown. As of March 2020, they had 33 runs. 26-Adair Co., 1-Clinton Co., 2-Barren Co., 1-Larue Co, 3-Wayne Co., for total of 2225 miles. As of March 2020, 22 under home incarnation for total of 511 days, which has saved the county \$16,863.00. Jailer Brown reported 2 prisoners are in the Adair Co. jail at this time.

Court recognized Cumberland County ABC Officer-James Smith Jr which gave his February report. The alcohol monthly sales as of February were \$ 90,242.12 year to date. Mr. Smith stated that ABC has collected monthly \$4,364.12 year to date.

Cumberland County ABC officer James Smith Jr. Mr. Smith ABC gave the report for November 2021. Total sales November were \$91,627.67. Year to date sales \$1,906,156.45. Regulatory fees for November \$4,531.67. Year to date regulatory fees es \$90,563.97. Two months left in the ABC fiscal year.

Visitor Cumberland County Sheriff Scot Daniels that December and January have been extremely busy. Two stolen vehicles in the past 2 weeks. #### ITEM 2

Visitors: Cumberland County Jailer Thomas Brown gave the jail report for February 2022 with 24 runs. 21-to Adair Co., 1-Henderson Co., 1-Clinton Co., 1-Hardin Co., for a total of 1,829 miles. As of March 14, Cumberland County has 30 inmates in the Adair Co. Regional Jail. In the month of February, 8 people under home incarnation for 121 days, saving the county \$3,993.00.

Cumberland County ABC officer James Smith Jr. Mr. Smith ABC gave the report for January. Total sales January \$79,033.97. Year to date sales \$2,080,603.70. Regulatory fees for January \$3,909.73. Year to date regulatory fees es \$99,183.96. Mr. Smith stated that \$44,266.66 more was taken in this year, compared to this time last year.

Visitor Cumberland County Road Foreman Ricky Melton addressed the court and thanked all other entities in county that work with the road crew at anytime and any place when ask. He also thanked the court for the hard decision they are faced with. Mr. Melton ask the court to consider giving the road department a raise in this next budget. These boys make a little over \$9.00 per hour and with rising prices of everything across the board, they can't survey and we are losing men to better paying jobs.

Visitor Jimmy Carter addressed the court. Mr. Carter is running for State Representative for 21<sup>st</sup> District on the Republican ticket. Mr. Carter lives on the Monroe co. side of Kettle Creek Community and for 15 years served as a police officer. Also served as a sergeant with the KY State Parks Dept. at Dale Hollow State Park. He's also a veteran. In 2020 Mr. Carter was in an accident that left him with a

limp but it hasn't stopped him from wanting to service the people. Mr. Carter ask that everyone please consider him for State Representative for this area.

Visitor Terry David Dubree addressed the court. Mr. Dubree is also running for State Representative for the 21<sup>st</sup> District. Mr Dubree is a Republican and a Monroe County native. He is also a veteran and a WKU graduate. Mr. Dubree ask that everyone please consider him for State Representative for this area.
