
Dear Ms. Bridwell:

Please see the attached summaries for the Water Loss Surcharge Fund. On June 12, 2024 the District received notification from the Commonwealth of Kentucky that reimbursements from KIA will be deposited within three days into the Districts bank account. Attached with this letter is the email that was received with this information. In the Commission's order from April 13, 2023 the Commission approved the District to use \$88,576.00 from the Surcharge Account to fund an emergency stream crossing and \$48,412.93 to be temporarily used that would be reimbursed back into the Surcharge Account once the Grant was awarded. The District will reimburse the Surcharge Account \$48,412.93 as soon as the funds are available.

500 Mach-10 meters were ordered by the District in March 2024. These meters and invoice have arrived this month and will be paid in full which will be shown on June's bank Statement next month. 500 more Mach-10 meters have also been ordered. The District continues to seek a full time leak detection employee as well.
