MOTION FOR REHEARING

Pursuant to KRS 278.400 and 807 KAR 5:001, Section 5, Big Sandy Water District (“Big Sandy District” or “the District”) moves for rehearing on the Public Service Commission’s (“the Commission”) Order of May 1, 2025 in this matter for the purpose of obtaining a ruling on that portion of District’s motion for authorization addressing the use of Water Loss Reduction Surcharge (“Surcharge”) proceeds for certain water main improvement projects.

In support of its Motion, the District states:

1. On January 27, 2025, the District submit a Notice of Amendment to Infrastructure Improvement Plan and Motion for Authorization for Use of Surcharge Proceeds. In its Motion, the District sought authorization from the Commission to use Surcharge proceeds for, *inter alia*, two water main replacement projects - the Bear Creek Road and the Friendship Road Replacement Projects. In its Motion, the District described the need for those projects, provided a detailed breakdown of each project’s costs, and set forth its plan for funding those projects.


2. On May 1, 2025, the Commission issued an Order authorizing the use of Surcharge proceeds for the purchase of a hydro excavator and ten zone meters and the reimbursement of the cost of the engineering review of the water main improvement projects contained in the District’s Amended Infrastructure Improvement Plan.

3. The Order of May 1, 2025, however, is silent on the proposed use of Surcharge proceeds to fund the Bear Creek Road and the Friendship Road Replacement Projects. It does not address the request or acknowledge that such a request is set forth in the District's Motion.

WHEREFORE, Big Sandy Water District respectfully moves for rehearing on the Order of May 1, 2025, and requests the Commission amend that Order to address and grant the District's request for authorization to use Surcharge proceeds for the Bear Creek Road and the Friendship Road Replacement Projects.


