The Beech Grove Water System has used their employees to search, locate, and repair water leaks every day for average of two hours a day. Beech Grove Water System has found and repaired over ten (10) water leaks in this year. Beech Grove Water System found a major water leak in the bottom of West Fork Knoblick Creek on a (six) inch 6" water main.

Beech Grove Water System has found most of the water leaks on ¾" and 1" size service lines. Some of theses leaks were at vacant lots that hasn't been used for years.

As of today October 25 2023, Beech Grove Water System has spent approximately \$31,455.00 to repair water line leaks. Beech Grove Water System is still searching for additional water leaks each day.

Beech Grove Water System collects a monthly water surcharge fee of \$6.30 per customer for 48 months or until \$177,304.00 has been collect whichever occurs first. As of September 30 2023, Beech Grove Water System has collected \$38,488.28 in surcharge fees. Beech Grove Water System has not used any of the water surcharge money for repair to water lines or purchase any type of equipment.
