Comes now Taylor County Rural Electric Cooperative Corporation ("Taylor County"), by counsel, pursuant to 807 KAR 5:001, and other applicable law, and does hereby request the Kentucky Public Service Commission ("Commission") to issue an Order approving the establishment of a regulatory asset for expenses incurred for maintenance of its overhead lines for GPS/tagging of its electrical poles by January 31, 2023, respectfully stating as follows:

- 1. Taylor County filed its Application in this proceeding on October 14, 2022. The Application requested the Commission to approve the establishment of a regulatory asset for certain overhead lines maintenance expense for the GPS/tagging it is electrical poles.
- 2. In order to properly book the regulatory asset in 2022, Taylor County will need approval to establish the regulatory asset by the time Taylor County closes its books for year end 2022.
  - 3. There have been no motions for intervention filed.

4. To date, no action has been taken on Taylor County's October 14, 2022 Application.
