**MOTION FOR EXTENSION OF TIME**

---

The City of Harrodsburg (“Harrodsburg”), by counsel, respectfully moves the Public Service Commission for an Order extending the deadline by which Harrodsburg must file its responses to the Commission’s Initial Request for Information contained in the Appendix to the Commission’s Order dated October 25, 2022. Specifically, Harrodsburg requests that it be allowed an additional two weeks, until Monday, December 12, 2022, to file its responses.

In support of this Motion, Harrodsburg states that additional time is necessary to adequately review, compile, and confirm the information and documentation Harrodsburg must provide to respond to the Commission’s Initial Request for Information. While Harrodsburg is endeavoring to provide its responses to the Commission’s requests for information as soon as practicable, it does not anticipate that it can produce the requested information by Monday, November 28, 2022, the allotted date of submission pursuant to the Commission’s Order. An additional two weeks is requested due to the occurrence of both the Veterans Day and Thanksgiving holidays between the date the Commission issued the Initial Request for Information and the date of required submission. These holidays have slowed Harrodsburg’s collection of documents from various departments responsible for maintaining the relevant records.

Harrodsburg understands the Commission's position on extensions of time and submits that good cause exists to ensure the City can provide the testimony, information, and records that the Commission has requested. The relatively brief extension of time sought herein is reasonable and will allow sufficient time for the Commission to render a decision in this matter on March 30, 2023. The Commission's set schedule, provided in the Appendix to its October 25, 2022, Order, contains deadlines related to the submissions from intervening parties. As no intervening parties entered this case, Harrodsburg's request for a two-week extension will not ultimately thwart the Commission's set timeline and requirement that Harrodsburg request a hearing or submit a decision based on the record by February 17, 2023, for a decision by March 30, 2022.

In granting this motion, it would be appropriate for the Commission to alter the remaining deadlines of the procedural schedule set forth in the Appendix to the October 25, 2022, Order. Harrodsburg proposes a two-week extension for each of these deadlines.

Accordingly, Harrodsburg requests an Order extending the deadline by which Harrodsburg must file its responses to the Initial Request for Information or before Monday, November 28, 2022.
