Comes now the Harrison County Water Association, Inc., by and through counsel, Mr. Jesse P. Melcher, Esq. and hereby submits the following response and notice of filing to The Kentucky Public Service Commission's ("Commission", referenced hereafter) request to correct deficiencies in filing to electronic application for a pass through rate adjustment pursuant to K.R.S. 278 and 807 KAR 5:068.

Whereas, the Harrison County Water Association, Inc., filed a pass through rate adjustment with the Commission as evidenced by the above case number on October 24, 2022, and wherein, the Commission noticed the Harrison County Water Association, Inc., on October 24, 2022, of two (2) deficiencies in the application, i.e., 1) need to submit copy of notice of increase from supplier, and 2) add to notice of request for pass through rate adjustment, the dollar and/or cent amount of increase for each class of rate schedules. Wherein, The Harrison County Water Association, Inc., as follows:

- A. The Harrison County Water Association, Inc. attaches the notice of supplier of the rate increase that was electronically filed with the Commission, which is attached hereto, and identified herein, as Exhibit "B" (consisting of nine pages; consisting of City of Cynthiana Tariff change, Notice from Supplier, Addendum to Contract, Letter to Commission dated September 15, 2022, Letter from supplier to HCWA, dated August 15, 2022, and the electronic filing receipt with the Commission dated 9/28/2022, as filed by the City of Cynthiana; all of which is attached hereto.

- B. Pursuant to 807 KAR 5:068, the Amended Notice has been posted at the front office door of the Harrison County Water Association, Inc. as of October 25, 2022, and will be posted on its website (i.e., [www.harrisoncowaterky.nexbillpayonline.com](http://www.harrisoncowaterky.nexbillpayonline.com)), until Order of This Commission, and all affected customers will be notified as follows:
- a) Notice is being placed in all five county news publications, with the highest circulation to all affected customers; Specifically, Harrison County Democrat; Harrison County Shopper; Bourbon County Citizen; Carlisle Mercury (Nicholas County); News-Graphic Georgetown (Scott Co.); Falmouth Outlook (Pendleton County).
  - b) Copies of those news publications, with publisher verification will be supplemented to the file; a copy of the notice is attached hereto and identified as Exhibit "A", being and fully incorporated herein, as if written word for word herein. It is requested that this amended notice supplement the previous Exhibit "A" to the electronic application for a pass through rate adjustment.
  - c) The Harrison County Water Association, to reflect the dollar and cent increase for the proposed pass through rates, attaches amended Exhibit "E"
