NOTICE OF KENTUCKY PUBLIC SERVICE COMMISSION

REQUEST FOR APPROVAL OF PASS THROUGH RATE INCREASE

All customers of the Harrison County Water Association, Inc., which serves most of Harrison County, and parts of: Scott County, Bourbon County, Pendleton County, and Nicholas County, Kentucky, PLEASE TAKE NOTICE OF THE FOLLOWING: The Harrison County Water Association, Inc., only distributes water it purchases, wherein, the primary provider of distributed water is the City of Cynthiana, Kentucky. The City of Cynthiana, will as of November 21, 2022, raise its rates of water sold to the Harrison County Water Association, Inc., by \$0.46 (i.e. forty-six cents) per one thousand (\$1,000.00) gallons sold. The current charged rate per 1,000 gallons purchased is \$3.15 and the new rate will be \$3.61 per one thousand (1,000) gallons purchased.

Therefore, pursuant to resolution and approved motion for a rate pass through adjustment for the Harrison County Water Association, Inc. to pass this rate increase along to its customers; all pursuant to KRS 278 & 807 KAR 5:068; The Harrison County Water Association, Inc. will begin charging **<u>\$0.51</u>** per 1,000.00 gallons purchased and/or used for each of its customers. This rate for each additional 1,000 gallons purchased and/or used shall be as follows (The current rate is reflected in the chart with the new proposed rate)

The Kentucky Public Service Commission must approve the pass through rate, and the rate case is currently being reviewed by the Kentucky Public Service Commission, Case No. 2022-00354.

THIS RATE DOES NOT REFLECT ANY PASS THROUGH FEES IMPOSED BY COUNTY GOVERNMENTS SUCH AS TAXES, FEES, 911 SURCHAGES, ETC.

The total pass through rate adjustment equates to fifty one cents (\$0.51) per one thousand gallons sold.

This rate increase, if approved, will begin December 12, 2022 meter reading period, which will be billed in the period of February 1-5, 2023. The proposed pass through would impose on an approximate average user who uses 4,500.00 (the approximate median use for HCWA, Inc., users), an increase of \$2.47 per month; i.e. the monthly bill would go from @\$41.66 to \$44.12, if approved.
